Signatures below, acknowledge our understanding of, agreement with, and intention of compliance with the terms and conditions of this Contractual Agreement for the Sale and Conveyance of the following puppy.

Financial Terms: In consideration of a purchase price of \$____, which has been paid-in-full, *for which this contract serves as a receipt*, the Seller transfers responsibilities associated with the ownership of the puppy listed and described above, to Purchaser as of the date indicated on the top of the page of this agreement.

Canadian Kennel Club: Puppy is registered with the Canadian Kennel Club (CKC) and embodies the basic standards of the breed. Puppy is sold as a companion puppy with a non-breeding agreement. Seller will provide full ownership registration papers upon proof of spay/neuter to the Seller.

Health Guarantee:

- Puppy is current on age appropriate vaccinations and worming at the time of sale.
- Seller guarantees puppy to be free of communicable viruses for 72 hours after Purchaser receives the puppy.
- Non-life-threatening ailments (such as hypoglycemia, hernias, or patella) are not covered by this guarantee.
- Seller guarantees puppy to be free of any life-threatening congenital defect for the first two years of life.
- For any remedy from Seller of said puppy, Purchaser must provide written veterinary confirmation to the Seller within 72 hours of veterinary diagnosis. If the claim is for the death, all documents from a licensed veterinarian, a formal necropsy, and cause of death will be sent to the Seller including microchip verification. If the claim occurs within the first 2 years of life and the claim is valid, the puppy will be replaced with one of equal value and of the same gender as puppies are available, with the Purchaser being responsible for all transportation costs. Prior to replacement of the puppy, the original CKC papers must be signed and returned to the Seller.
- Purchaser acknowledges that no veterinary bill incurred by the Purchaser will be paid by the Seller.
- There are no guarantees offered for puppy's training, size, markings nor temperament.
- This guarantee is non-transferrable to a third party.

Purchaser Agrees to:

- Maintain puppy's health and proper weight with annual veterinary examinations. To provide vaccinations and care as specified by their veterinarian as well as to provide a good diet, and a clean, safe environment.
- Have puppy spayed/neutered by 12 months of age for continued good health.
- Return puppy and signed CKC papers to the Seller if the Purchaser can no longer provide for the care of puppy.

Limitations and Exclusions: No other warranties or guarantees, expressed or implied, are made under this contract except as stated above. Any modifications to this agreement must be attached to this document and agreed upon by both Seller and Purchaser, complete with signatures of all parties. Any disputes regarding said puppy, Purchaser or Seller shall be settled only in Kars, ON.
